CIRCULAR **Investment Schemes**

Respected members of the Society are informed through this circular that, as per the decision taken by the Board of Directors, **all types of deposits (new and renewal) and other investment schemes will be restarted w.e.f. 21.10.2020.** The interest rate on deposits will be as under: -

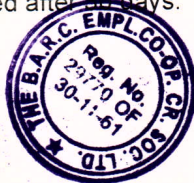
1. **FIXED DEPOSIT :** 1 Year @7.0% , 2 Years @7.25%, 3 Years @ 7.50%
2. **TERM DEPOSIT :** 3 to 6 Months @ 4.5%, 7 to 11 Months@5.5%
3. **RECURRING DEPOSIT:** 1 Year@7.00% , 2 Years @7.5%, 3 Years @7.75%
4. **LAKHPATI :** Rs.1120/- per month for 72 months to get Rs.1,00,000/-

1. Deposit Sr. No. 1 & 2: Application for these deposit scheme (new and renewal) will be accepted from 21.10.2020. Those members whose deposits matured before 21.10.2020 and that matured amount is in the form of deposits with Society, if they apply for renewal within 60 days from 21.10.2020, those deposits will be considered for renewal from 21.10.2020 at the new interest rate.
2. Investment schemes: For Sr. No. 3,4,5,6,7,8 investment schemes monthly installment will be accepted through salary & while starting the investment, applications will be accepted for that upto 10th of that month.
3. For Sr. No.9 investment: Applications will be accepted upto 13.11.2020.
