**1. Scope of work:**

1.1 Thorough cleaning, servicing, testing of Air Conditioner units and Door Air Curtain unit, replacement of parts needed for proper operation.

1.2 To repair defects during the currency of the contract.

1.3 To keep the equipment in up-to-date condition during the currency of the contract.

2. Rates should be quoted as per item wise as noted in table no. 1 of tender document.

3. **Work Experience:** Vendor should have previous experience of maintenances of Air Conditioner units and Door Air Curtain unit,

4. Vendor shall submit their previous AMC work order copy if any, for Air Conditioner units and Door Air Curtain unit.

5. **Work order period** - 1 year (AMC will be given for whole financial year.)

6. **Mode of payment** - Payment shall be made on half year basis.

7. **Emergency Call:** Emergency/Breakdown call from the user should be attended immediately but not later than 24 hours at no extra cost.

8. **Service Visit:** The firm shall be complete 03 maintenance visit (for each unit) during the AMC Period (12 Months)

**9. Replacement of spare parts:**

The cost of the spare part replaced during the currency of the contract will be paid extra at actuals. However, the parts may be replaced with approval of user regarding the reasonableness of cost and necessity of replacement

10. While the contract is intended to be valid for a period of one year, this Board of Directors reserves the right to terminate this contract by giving a notice of one month and without any financial obligation on the part. In the event of cancellation of the contract for any reason or the other the payment for service carried out will be paid on pro-rata basis.

11. Proportionate amount shall be deducted from AMC charges for non-servicing period.

12. Board of Directors reserves the rights to accept or the reject the quotation.
