- 3. Base should be made ABS (plastic)/ Polypropylene
- 4. Base color Black/Brown
- 5. Height 11" to 12"
- 6. Top Shape As per enclosed sketch,
- 7. Middle shape- As per enclosed sketch,
- 8. The bottom plate will contain the society name (rectangular shape) and logo (circular shape) in golden/silver color.
- 9. Description and design of society name plate and logo shall be given by society.
- 10. All corners of memento base and plate shall be chamfer, smooth and glossy finishing.
- 11. Weight 300 to 400 grams.
- 12. Rough sketch Enclosed in tender document.
