2. **Work Experience:** Vendor should have previous experience of supply, installation and maintenances of CCTV camera System.

3. **Work order period** - 1 year (from date issue of work order.)

4. **Emergency Call:** Emergency/Breakdown call from the user should be attended immediately but not later than 24 hours at no extra cost.

5. **Service Visit:** The firm shall be complete minimum 4 maintenance visit during the AMC Period (12 Months)

**6. Replacement of spare parts:**

The cost of the spare part replaced during the maintains of the contract will be paid extra at actuals. However, the parts may be replaced with approval of user regarding the reasonableness of cost and necessity of replacement.

7. While the contract is intended to be valid for a period of one year, this Board of Directors reserves the right to terminate this contract by giving a notice of one month and without any financial obligation on the part. In the event of cancellation of the contract for any reason or the other the payment for service carried out will be paid on pro-rate basis.

8. **Payment terms** – Payment shall be made on half yearly basis.

9. **Mode of payment** – NEFT /RTGS

10. **TDS:** - Applicable TDS Will be deducted from your bill.


11. **Work timing** – 9.30 am to 5.30 pm,
